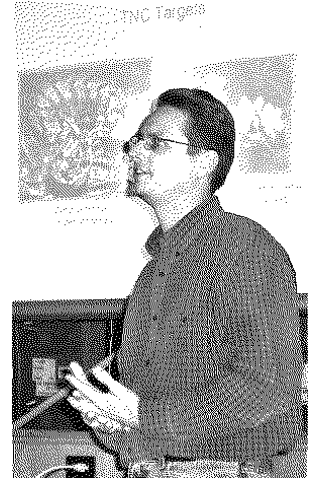

### Van Clef Talk: New Jersey's Least Wanted List

Michael Van Clef, botanist with the Nature Conservancy, is a man on a mission! This January at a joint KGA and Kingston Garden Club meeting, Dr. Van Clef presented an overview of New Jersey's most problematic invasive plant species, including his top five: multiflora rose, garlic mustard, Japanese stiltgrass, purple loosestrife, and barberry. He explained why each was a threat to our preserved open space and went on to suggest control measures and non-invasive alternatives.

He also spoke about overgrazing of undergrowth and the importance of deer control, a measure made necessary by the disappearance of woodlands due to New Jersey's overdevelopment. There was a lively discussion: a good omen, since it is important that we in the KGA understand these topics so that we can have informed opinions on the Green Belt land management.

## Princeton Nurseries Property News

In the last issue of *The Green Way*, we reported on the transfer of part of the Princeton Nurseries land from Princeton University to South Brunswick Township. On January 19<sup>th</sup>, the second ceremony was held, this one for the completion of transfer from Princeton Nurseries, Inc. and Princeton University to the State of New Jersey and South Brunswick Township. South Brunswick mayor Frank Gambatese and NJ Department of Environmental Protection and Energy Commissioner Bradley Campbell presided over the ceremony. The division of the lands and structures between South Brunswick and the Delaware and Raritan Canal State Park is very complicated, and the plan for developing recreational opportunities has not been worked out yet.



The Friends of Princeton Nursery Lands will pursue the goal of providing citizen input and financial support to the park preserve, much as the Rockingham Association supports programs at Rockingham State Historic Site. The KGA is assisting the Friends of Princeton Nursery Lands as they develop a mission and officers, and apply for non-profit status.
